20th Annual Arts & Crafts Outdoor Festival

CATEGORIES and AWARDS: (Limit three (3) entries for each category)

1. Painting (all media including Photography)
2. Three-dimensional Art (including Glass and Fiber)

A Best of Show will be presented in each category as well as Merit Awards. The public will vote for a People's Choice during the Festival.

JUROR: TO BE ANNOUNCED

ENTRY GUIDELINES:

1. All work must be original, designed and executed within the last two years. No copies of work done from commercially prepared kits or molds will be accepted.
2. Entries for the 2009 juried show will be by digital imaging (jpeg) on CD.
3. Entry fee: \$10.00 for the first item entered in a category. For two entries in a category the fee is \$17, for three entries in a category, \$24. Fees must accompany the CD and are not refundable. Send check or money order. Do not send cash.
4. All accepted entries must be framed and equipped for exhibiting and handling. No frames with exposed glass edges will be accepted. All art must be ready to be hung for display with picture wire.
5. Maximum size (category 1) including frame not to exceed 36" horizontally and/or vertically. Maximum size (category 2) not to exceed 3 feet in height. Maximum weight (category 1 & 2) not to exceed 45 lbs.
6. No entry of a fragile nature shall be accepted such as unfired ceramic or plaster or unsupported glass. All entries will be moved and hung by volunteers.
7. All items must be for sale; the price designated on entry. A 20% commission will be charged.
8. Sales Tax: The sales tax on sales from the juried show will be charged, collected, and remitted to the State of Idaho by the St. Maries Council for the Arts under the direction of the festival committee.
9. Submit digital entries in jpeg format on CD. Label the CD with the artist's name and title(s) of the work(s) numbered to correspond with the numbers on the entry form. Label each file on the CD with the title of the work or an obvious abbreviation of that title.
10. **All entries to be postmarked by May 22, 2009. Mail the CD, the entry form, the fees and a self-addressed, stamped envelope large enough to return the CD in to: s.m.ART by the River – Juried Show, St. Maries Council for the Arts, 704 Main, St. Maries, Idaho 83861**
11. Entries that are not accepted for the show will be returned by mail. Accepted entries will be notified at the end of June and the actual artwork is to be received by July 17, 2009 but not before July 11. Shipped entries must be in a reusable container and accompanied by a self-addressed label. Ship to smART Juried Show, St. Maries Council for the Arts, 704 Main, St. Maries, Idaho 83861. On Friday, July 17, HAND DELIVERED ENTRIES will be accepted at the smART site, Cherry Bend Boat Park, St. Maries, ID, in the Juried Show Tent from 4:00 to 7:00 p.m.

TO RECLAIM WORK:

Work that has been exhibited must be reclaimed after the show, or provided with a self-addressed container and packing material that will be shipped C.O.D. to the artist. Bring the notification card to the Juried Show Tent on July 19, after 5:00 p.m. to pick up work. No work will be released before 5:00 p.m. All work must be picked up by 6 pm.

LIABILITY:

Although every precaution will be taken to protect all art on display, the festival will assume no responsibility for loss, which might be sustained due to fire, weather, theft, or damage.

The festival committee disclaims responsibility for any artwork not claimed by 6:00 p.m. on July 19, 2009.

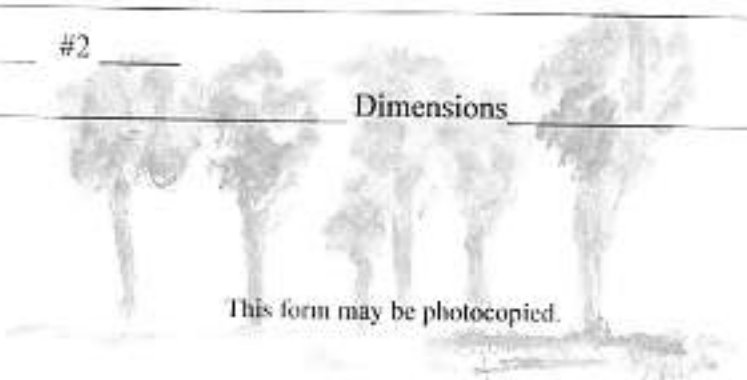
